

**ARTICLES OF INCORPORATION
OF
THE ORIGINAL HIGH PLAINS REGIONAL RENDEZVOUS ASSOCIATION**

ARTICLE I

The name of the corporation shall be **THE ORIGINAL HIGH PLAINS REGIONAL RENDEZVOUS ASSOCIATION.**

ARTICLE II

The purpose for which the corporation is formed is to organize, operate and maintain an association for the educational, civic, patriotic and cultural purposes, on a not for profit corporation basis, including preservation and benefit of historical re-enactments of the Fur Trade era prior to and including 1840.

ARTICLE III

The duration of this corporation is perpetual, unless sooner dissolved according to law.

ARTICLE IV

The corporation shall not devote more than an insubstantial part of the corporation's activities to attempting to influence legislation by propaganda or otherwise, and shall not directly or indirectly participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE V

The corporation shall be non-stock and no part of the net earnings of the corporation shall inure to the benefit of or be distributable to members, directors, officers or other private persons. However, the corporation may pay reasonable compensation to any person for services rendered.

ARTICLE VI

The number of directors constituting the initial Executive Board of administrators shall be nine, and the names and street addresses of the persons who are to serve as the initial directors until the first annual meeting of the members of the Corporation are as follows:

ARTICLE VII




ARTICLE VIII
